## **FEI COMPETITIONS**

*All Foreign and National Riders must be approved by their NF, inform their FEI Registration Number and present passport or birth certificate at the Technical Meeting. Any rider not in compliance may not ride.*

*The first countries to register will be given priority for confirmation of participation.*

*The National Federation of Ecuador strongly recommends the NFs invited, to select the riders among their best-ranked riders.*

**Art. 4103.5 International Events with Borrowed Horses.**

The same rider and horse can only participate in one category.

**Children C:** For countries that have in their own Rules and Regulations, established competitions for Children from the year they reach 10 to the end of year they reach 12 years.

**Children B:** Art. 4102 From the beginning of the calendar year in which he reaches the age of 12 until the end of the calendar year in which he reaches the age of 14.

**Junior B:** Art. 3.2 From the beginning of the calendar year in which he reaches 14 years of age until the end of the year they reach 18.

**Invitational B:** For riders 18 years old or older.

National riders: only Category "B"

**TEAM COMPETITION**

The two riders who share the same horse will form teams.

Results: by adding their jumping faults on the First and Second Qualifying competitions. If there is a tie in accumulated scores for any of the three best-scored teams, the classification will be according to the addition of the time of the two riders on the second competition.

**INTERNATIONAL EVENTS WITH BORROWED HORSES Art. 4103.5**

**Art. 4103.5.2.4** Each rider of the host country provides one horse. A draw takes place to match foreign riders with host country riders. Each horse is ridden by a host country rider and by a foreign rider. In the first competition, the host country rider rides his horse first.

**Art. 4103.5.1** Sufficient reserve horses must only be provided for foreign riders. Those horses that are obviously unsuitable for foreign riders must be replaced by reserve horses. Such a substitution may only be done with the approval of the Ground Jury.

**Art. 4103.5.3.2** Each foreign rider will be given the opportunity to school the horse obtained in the draw at least once.

**Art. 4103.5.3.3** Not more than a total of six obstacles may be jumped during any training session. Cross poles are not included in the above number.

Three attempts at jumping an obstacle count as one obstacle jumped. One double or one triple counts as one obstacle.

**Art. 4103.5.3.4** The OC will establish the Rules governing schooling sessions.

**Art. 4103.5.3.9** The horse must be ridden using the bit which he usually works with. The bit may be changed only with the agreement of the owner.

**Art. 4103.5.4.3** In the first competition, horses must be ridden first by the riders of the host country.

**Art. 4103.5.4.4** If there are not sufficient foreign riders to match the number of host country riders and horses, there will be a draw among foreign riders to decide which foreign riders will ride the surplus horses, in order to ensure that all horses start twice per day.

There will be another draw for the starting order for First and Second Qualifying Competitions.

The starting order for Final "A" and "B" Competitions will follow the reverse order of penalties incurred in First and Second Qualifying Competitions. The competitor with the greatest number of penalties will start first. In the event of equality of penalties for any placing, the time of the 2nd Qualifying Competition will be the deciding factor for the starting order.

Any rider with 2 horses should ride first his horse for the championship in each competition. For him, this horse only, can be eligible for "Final A" Competition. His second horse will count only for First and Second Qualifying competitions and Team Competition.

*Each rider can only participate in one of the two Finals Competitions.*

### **SCHOOLING DURING INTERNATIONAL COMPETITIONS Art. 4103.5.3**

Stewards will post the schooling schedule immediately following the Technical Meeting.

### **ELIMINATIONS**

If a competitor is eliminated or retires from the First or Second qualifying competition, he shall be penalized with 20 points more than the rider with the highest number of penalty points.

The eliminated or retired rider in any Qualifying Competition will be automatically classified to " Final B".

### **HORSES**

According to F.E.I. rules, all horses from the international competitions must remain in Quito Tennis & Golf Club during the event.

All horses must present the following:

- 1) Must have tested negative for Equine Infectious Anemia and present a valid certificate.
- 2) Vaccination against Equine Influenza.

### **Art. 116.5**

*In the case of a borrowed Horse, the Person Responsible is also the competitor, but the owner or the person who is normally in charge of the Horse may be considered as an additional Person Responsible.*

## **1. PRIZE – CLASSIFICATION**

There will be a "Final A" Competition for Children C, Children B, Junior B and Invitational B riders. This competition is compulsory for the 20 best placed competitors and horses (including those placed equal for the 20th place) according to the accumulative penalties over the first and second Qualifying competition (faults only).

There will be a "Final B" Competition for the rest of the riders.

All the riders start each Final Competition without points.

**The Final Competition defines the result of the Championship.**

The winner rider of the "Final A" Competition will be declared "Champion".

The time for the 1st. and 2nd. Qualifying competition is only for the results of the day and will not be considered for the accumulated score.

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and Athletes must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the

event.

4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
- 5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.**

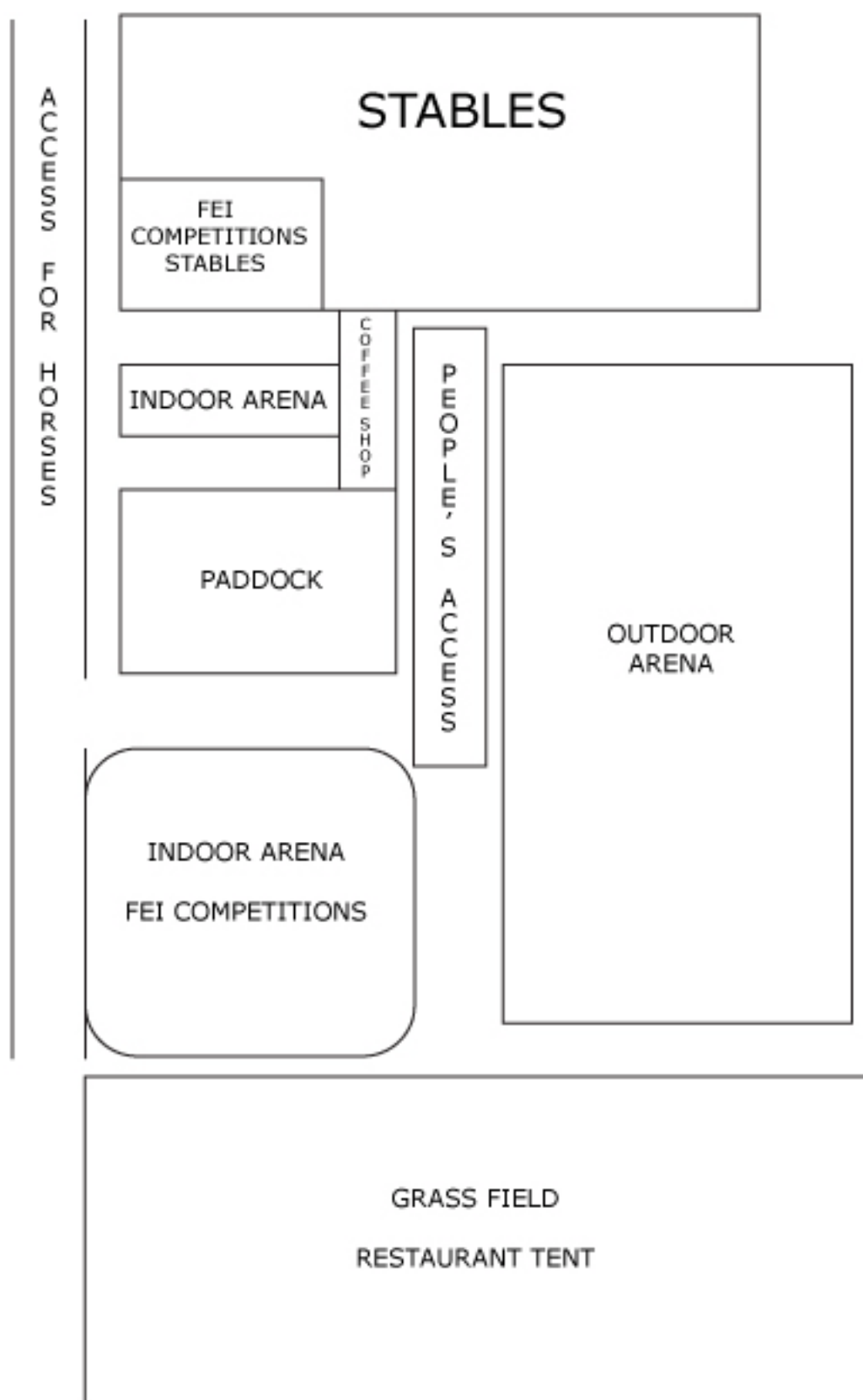

**IMPORTANT**

The value of the 1<sup>st</sup> prize must not exceed 1/3 of the total prize money distributed for the competition. The minimum number of prizes offered for each competition must be allocated on the basis of one prize for every commenced four Athletes, with a minimum of five prizes. The total amount of prize money shown for each Competition in the schedule must be distributed. (GR Art 127, 128)

The retail value of all prizes in kind must be mentioned as well as detail of model, type and special features for cars.

**Instructions for breakdown of prize money:**

- Maximum 1/3 of the total prize money for the competition to the winner.
- Break down for 1<sup>st</sup> to 8<sup>th</sup> place (at least) in a reasonable descending order of distribution must be listed in the Schedule.
- The minimum amount the last placed competitor receives must be indicated in the Schedule.
- Minimum 25% of competitors must receive prize money (one prize for every four starters), however minimum 5 prizes if there are 20 or fewer athletes taking part in the competition.
- The FEI has the right to alter the amounts proposed for distribution if the necessity arises.
